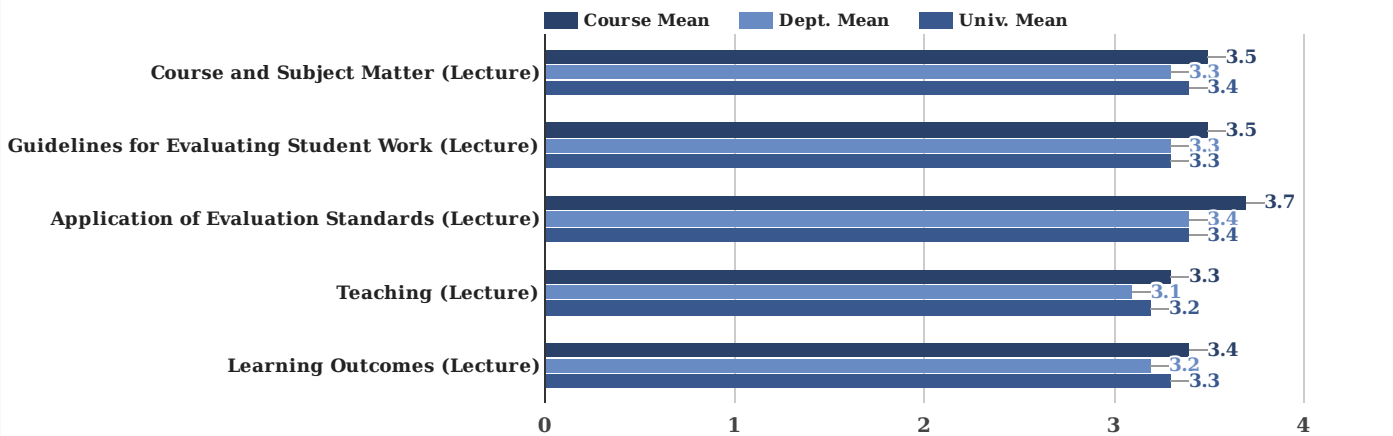

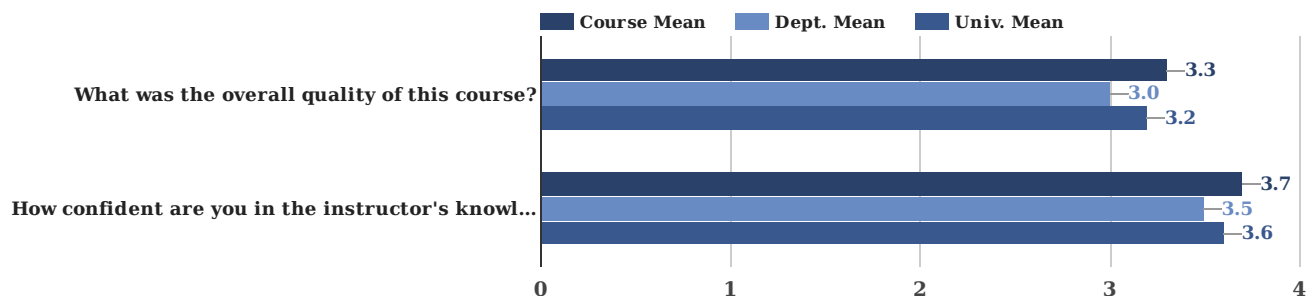
- 1. interpret financial and monetary policy news, as well as Federal Reserve policy announcements.**

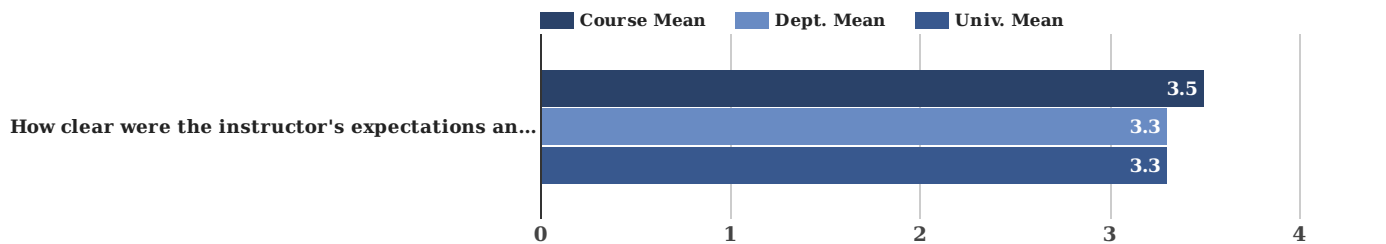

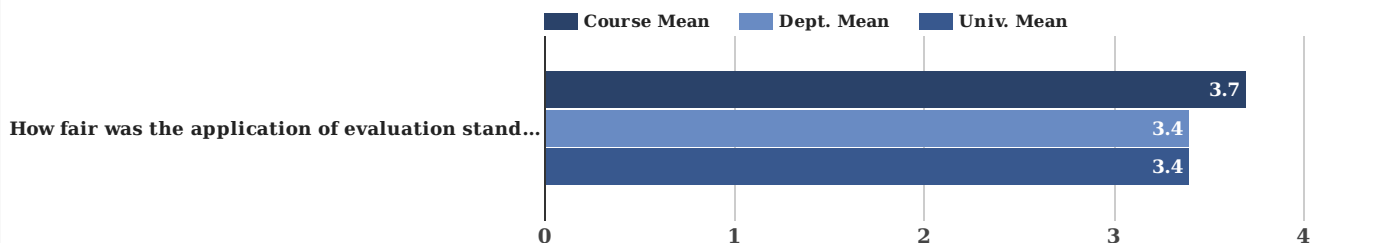

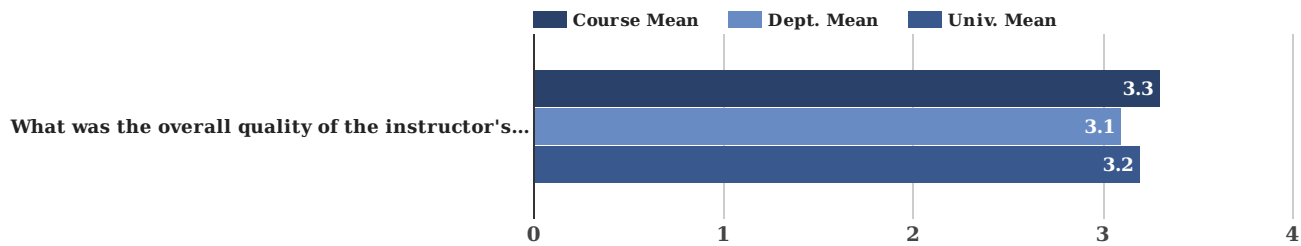

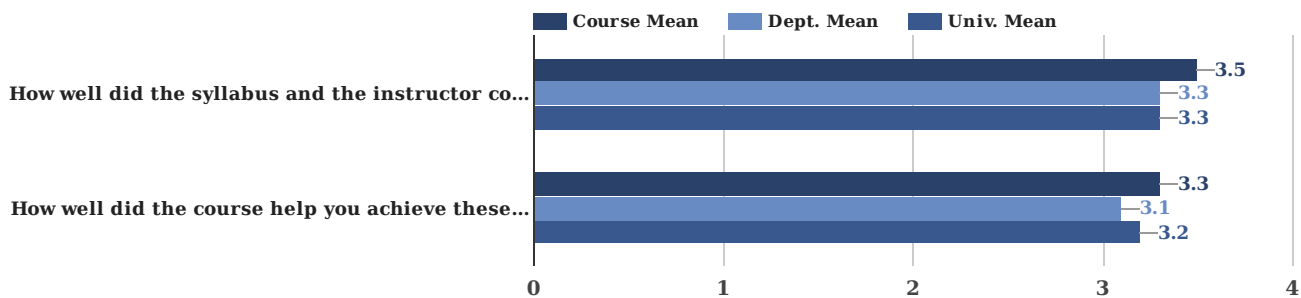

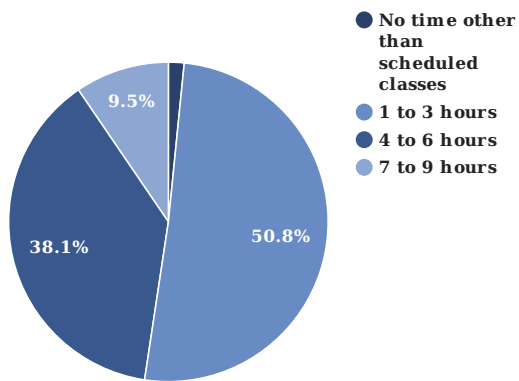
